STAFF REPORTS

ROAD AND BRIDGE REPORT

Road and Bridge Supervisor, Gary Hyde, met with the board to give the monthly report for March. Gary informed the board that the three water trucks that they currently have are not equipped properly to haul a full load of water. The front axles would have to be replaced in order for them to be compliant. Instead of going to the expense of fixing the old trucks, Gary would like to replace them. He presented the board with several options he is looking at. The board felt that purchasing three new trucks was the best option. However, the financing would be through a bank in Kansas that Bruckner Truck Sales Inc. uses and they wanted Gary to pursue financing with the local bank to see if they could give him the same, or better, deal.

MOTION by Commissioner Canda, to authorize the purchase of three new water trucks through Bruckner Truck Sales Inc., with \$90,000 down payment, and with the caveat that Gary check on financing through the local bank. Motion carried unanimously.

LANDFILL REPORT

Landfill Supervisor, Rusty Christensen, met with the board to give the monthly report for March. Rusty would like to have a meeting with Golder Associates, Inc., an engineering firm, to start going over the landfill expansion planning. The board told him to try to set a meeting for April 18th.
