NEW BUSINESS

ATTAINABLE HOUSING / EL POMAR GRANT

Attainable Housing Chair, Charles Bogle, explained to the board that the El Pomar Foundation's Central Peak Council would like to award Custer, Chaffee, Fremont, and Park counties each with a \$40,000 grant to be used towards affordable housing initiatives. The only limitations on the grant funds are that they cannot be used for studies or operational expenses. Charles presented the board with a draft of what Custer County Attainable Housing proposes to use the grant funds for.

MOTION by Commissioner Flower, to approve the draft plan to go towards obtaining a \$40,000 El Pomar grant. Motion carried unanimously.

RE-OPENING A PORTION OF COUNTY ROAD 386

U.S. Forest Service Forestry Technician, Jeff Outhier, met with the board to discuss re-opening a portion of County Road 386, which was closed in May 2017 due to flooding and landslides following the Junkins Fire. Jeff stated that the Forest Service felt that it was safe to re-open the upper end of County Road 386 where it intersects with Highway 165. County Attorney, Clint Smith, drafted Resolution 17-09 for this purpose.

MOTION by Commissioner Printz, to adopt Resolution # 19-04 "A Resolution by the Board of County Commissioners for Custer County re-opening a portion of Custer County Road 386 previously closed in its entirety by Resolution no. 17-09". Motion carried unanimously.

RESPONSE LETTER TO UPPER ARKANSAS WATER CONSERVANCY DISTRICT (UAWCD)

Commissioner Printz presented the board with a letter he drafted in response to an email that was sent to Commissioner Canda from UAWCD General Manager, Terry Scanga. The email was requesting that the BOCC put together a committee that would meet with the water augmentation blue-line committee. The board felt that this should have been done prior to UAWCD filing the water augmentation plan.

MOTION by Commissioner Printz, to approve, sign and send the letter to Upper Arkansas General Manager, Terry Scanga, and copying all the UAWCD board members. Motion passed unanimously with amendment.
