#### PLANNING AND ZONING REPORT

# **NEW BUSINESS**

# SB-35 WAIVER IN TV HILLS SUBDIVISION

TV Hills I was developed in 1977 and has ten lots. A community well services all ten of these lots plus three other properties not in the subdivision. TV Hills lot owners Ron and Debbie Gifford, Matt Gifford, and Sandy MacKinnon informed the board that the community well is starting to fail. It is down to eight gallons per minute. They applied for three well permits to drill a well on each of their lots but were turned down by the state. They requested that the BOCC give them a SB-35 waiver so they can drill the wells. After discussion, the board informed them that they will need to do more research and then present their case to the Planning Commission.

# **RESOLUTION 19-04**

This resolution allows the county to accept a donation from MBOGO Aviation LLC (Aught Six) in the amount of \$3,600 to be used at the airport.

MOTION by Commissioner Printz, to approve Resolution 19-04 "A Resolution appropriating additional sums of money to defray expenses in excess of amounts budgeted for Custer County". Motion carried unanimously.

# LANDFILL EXCAVATION

Landfill Supervisor, Rusty Christensen, is having trouble getting a scraper rented to dig a pit at the landfill. After discussion, the board decided to put out a request for proposal (RFP) to see if it would be cost effective to hire someone to do it rather than renting a scraper and Rusty doing it himself.

#### PUBLIC HEALTH AGENCY LEASE WITH CLINIC

County Attorney, Clint Smith, sent a letter to the Custer County Medical Center letting them know that the county is terminating the lease with them for the Public Health Agency office space, effective May 31<sup>st</sup>. The lease states that "with cause" you can give a 30-notice; "without cause" requires a 90-day notice. Clinic Executive Director, Lisa Drew, spoke with Public Health Agency Director, Elisa Livengood, about this. Elisa offered to pay half of what would be owed for another two months. The BOCC stated that Elisa did not have the authority to make this offer. Clint stated that he has heard nothing from Lisa regarding the letter he sent, and he recommended to the board to move ahead as planned.
